## Show Rules

1. **WPCSA Rules shall prevail.** Any rule changes will automatically be incorporated into this show. Rule Books will be in the show office for reference, exhibitors are requested to have a working knowledge of WPCSA rules. Every entry at a WPCSA sanctioned show shall constitute an agreement between the exhibitors, SOWPCA, this arena, and the WPCSA. The agreement is written in full on the entry form, participation acknowledges acceptance of all rules pertaining to the show.
2. **Eligibility:** All Ponies/Cobs must be registered in the studbook of the Welsh Pony & Cob Society of America, or, if under one year of age, must be eligible for registration. A Pony/Cob must be shown under its full registered Welsh Name and Number. All lease agreements must be officially recorded through the society office. All recorded leases are designated as such on the Pony/Cob's Registration Certificate. Half Welsh must be registered with WPCSA. Animals from foreign recognized registries may show but their WPCSA points will not count.
4. **Entries:** A Copy of **BOTH** sides of the Registration Papers **MUST** accompany each entry. If you have a USEF or WPCSA Permanent Measurement Card, or a measurement form from a current year's show, please include it with your entry. Please take the time to fill out your entry form correctly and completely. Exhibitor numbers will not be issued until **ALL** required paperwork, measurement, if required, and payment for all fees are completed.
6. Stallions, with the exception of current year's foals, are to be handled by an adult 18 years or older. **Unruly animals of any sex will be excused.**
7. **JUNIOR EXHIBITORS MUST WEAR APPROVED PROTECTED HEADGEAR (ASTM/SEI) WHENEVER MOUNTED OR IN A DRIVEN VEHICLE AT ALL TIMES WHILE ON THE SHOW GROUNDS, AND IN ALL RIDDEN CLASSES INCLUDING WESTERN CLASSES.**  
**Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.** Adult western and stock seat exhibitors may wear protected headgear without penalty. This also applies to Drivers, if they choose to wear a helmet.
8. A junior is 17 & under, an adult is 18 & older. Age for competition year is defined as starting on Dec 1<sup>st</sup> and Ending on Nov 30. Example, if you are 17 years old on Dec 1, 2010 you will compete as a junior until Nov 30, 2011 even though you turn 18 during the competitive year.
9. WPCSA preceding a class indicates the class is eligible for national points, subject to WPCSA rules. Owners and equitation riders must be member of WPCSA for points to count. (WPCSA membership form is enclosed.)
10. Ribbons will be awarded 1<sup>st</sup> – 5<sup>th</sup> place. Stake classes pay to third place in addition to ribbons. To enter a stake class you must enter and show in one of the qualifying classes listed in the division of the show. All stakes classes will pay \$ 15.00 to first, \$10.00 to second, and \$5.00 for third. There will be no stakes payout for divisions with less than three entries. Stakes classes payouts will be presented the day of the show. WPCSA Performance Division Champions and Reserves will receive ribbons.
11. **Entries must be in the hands of the Show Secretary by July 14<sup>th</sup>. Please allow time for the United States Postal Service to deliver your entry.**
14. No smoking anywhere on the fairgrounds. No alcoholic beverages allowed on grounds. No golf carts, motorcycles, bicycles, scooters or skate boards allowed.
15. Dogs must be on lease and are not allowed in the showing or staging area of barns and arena
16. Wire Wheeled vehicles will be allowed in the WPCSA Carriage Driving Classes.
17. **Removing the bridle from an animal harnessed to a vehicle or leaving an animal unattended while hitched anywhere on the show grounds will result in instant elimination and removal from the show grounds.**

Any NSF checks must be replaced by cash, money order or cashier's check within 30 days, including all bank fees and/or collection fees, and a SOWPCA \$50.00 charge for returned checks. Failure to do so will result in a notice to WPCSA.

A veterinarian or medical statement is required for any request for refund of entry fees.

19. The show committee reserves the right to decline any entry and to return any entry before, during or after the show without being liable for compensation or damages. Exhibitors are notified that any act of discourtesy and/or disobedience to judges, official, staff or committee on the part of the owner or groom shall disqualify the animal and the owner will forfeit his entry and other fees.
20. One pony/cob per stall w/exception of mare and foal. No bedding will be provided, you must provide your own. No refunds on stalls once they are ordered. Extra nights before or after the show must be arranged with the fair grounds.  
Stalls will be marked, with a stall map at the end of the aisles. Please only stable your pony/cob in a stall assigned to you.
21. Please reserve in advance as RV hookups may be in short supply because of other events at the show ground. Please clean up your area of debris and manure.
22. Measuring times. Thursday July 28 2-8pm, Friday July 29 5-7pm.

**Directions to Fairgrounds:**

**From the South**, from Interstate 5 take Exit 33 to Central Point, turning right onto E. Pine St. Turn left at the next light on Penninger Rd. and proceed to Gate 5. You can see the Isola Arena, stables and RV parking.

**From the North**, from Interstate , take Exit 33 to Central Point. Turn left onto E Pine St, and cross over freeway to second light. Turn left onto Penninger Rd. and proceed to Gate 5. You can see the Isola Arena, Stables and RV parking.

### WPCSA CLASS SPECIFICATIONS

**WPCSA BREED CLASSES (Article 110.2)** - Animals are to be shown in hand at a walk and a trot except in group classes. Purebred Welsh to be judged 85% on breed type, conformation, way of going, quality and substance and 15% on disposition and manners. Natural reaching action is desired. Half-Welsh to be judged 85% on conformation, way of going, quality and substance and 15% on Welsh breed type, disposition and manners.

**WPCSA CARRIAGE DRIVING (Article 113.2)** - **(wire wheeled vehicles can be used if stated in prize list.)** Classes open to ponies/cobs/half-Welsh. In addition to the gaits detailed in the pleasure driving section (Article 113.1.11) (walk, working trot, strong trot, halt and rein back). Carriage driving also requires the slow trot where the animal should maintain forward impulsion while showing submission to the bit. Turnout to be judged 70% on the condition, fit and appropriateness of harness and vehicle, neatness and appropriateness of attire and overall impression; 30% on performance, manners and way of going. Working class to be judged 70% on performance, manners and way of going; 20% on condition and fit of harness and vehicle; 10% on neatness of attire. Obstacle/Cones to be judged 100% on performance. Refer to specifications in rulebook for the type of obstacle/cones classes being offered.

**WPCSA Obstacle – Timed Competition:** Not to exceed 20 obstacles (pairs of cones topped with tennis balls). Faults add seconds to total time. Fastest time Wins.

- 1) To be driven over a prescribed course of obstacles, the number of obstacles to be proportionate to the dimensions of the driving area. Not to exceed 20 obstacles.
- 2) After passing the starting line, the driver shall proceed through each obstacle in order to the designated finish line.
- 3) Course faults are scored as penalty seconds and are added to the driver's elapsed time. Placings are determined on a low total time basis. Ties for first will be decided by a drive-off.
- 4) Penalties:
  - a. Knocking over start or finish marker – 5 seconds
  - b. Knocking down or dislodging obstacle – 5 seconds
  - c. Break in Gait (cumulative over course) 1<sup>st</sup> break from trot – 5 seconds, 2<sup>nd</sup> break from trot – 5 seconds, 3<sup>rd</sup> break from trot – 5 seconds, 4<sup>th</sup> break from trot – elimination. Prolonged canter or walk - elimination
  - d. Disobedience and/or groom dismounting (cumulative over course) 1<sup>st</sup> incident – 5 seconds, 2<sup>nd</sup> incident – 10 seconds, 3<sup>rd</sup> incident – elimination
  - e. Starting before signal – elimination
  - f. Failure to cross starting line within one minute of signal – elimination
  - g. Off course – elimination
  - h. Outside assistance – elimination
  - i. Failure to carry whip – elimination
  - j. Use of a tie-down or overcheck – elimination
  - k. Breakage of harness or vehicle – elimination.

## WPCSA CLASS SPECIFICATIONS Continued

**WPCSA CHILD'S FIRST PONY (Article 115.2)** - Section A, B, C and half-Welsh, mare or gelding 12.2 hands and under, to be ridden by junior exhibitors at least four, but no more than 10, years of age. Riders to be suitably dressed in Hunt, Saddle or Western attire including protective headgear. Ponies to be shown at a walk and trot or jog, both ways of the ring. **Ponies to be judged** on performance, manners and suitability. Conformation, way of going, manners, suitability and turnout to be emphasized. This is not an equitation class. **There are no restrictions for the pony or rider.**

**WPCSA HUNTER SEAT EQUITATION (Article 114.3)** - Classes open to ponies/cobs/half-Welsh. To be judged on the rider's appearance, seat, hands and control of their mount. Animals 13.2 and under jump 2'; animals over 13.2 jump 2'6".

- Over Fence (o/f) classes: to be shown over a minimum of six obstacles.
- Under saddle (u/s) classes: to be shown at a walk, trot and canter both ways of the ring. Test may be required.

**WPCSA JUNIOR WELSH HANDLER (Article 115.6)** - Judged on the ability and skill of the Junior in handling their pony/cob/half-Welsh as in the breed ring. The show qualities of the pony/cob/half-Welsh shall not be considered, although cleanliness and grooming can be considered. Exhibitors enter to the left so as not to obscure the judge's view. The judge evaluates the ability of the junior to follow directions, use space wisely, and execute the requested patterns. Juniors should appear "ring wise", be alert to the judging progression and be prepared for changes in the judging routine.

**WPCSA LEADING REIN (Article 115.1)** - Section A, B, C or half-Welsh, mare or gelding, 12.2 hands and under, to be ridden by junior exhibitors at least four, but not more than eight, years of age. **Ponies to be judged** on manners, suitability, breed type, conformation and turn-out. This is not an equitation class. **There are no restrictions for the pony or rider.**

**WPCSA LEADLINE WALK (Article 115.4)** - Classes open to riders 7 & under mounted on ponies/cobs/half-welsh, mares and geldings. Judged on equitation and suitability of mount at a walk. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk-trot, and leadline walk-trot poles.

**WPCSA LEADLINE WALK-TROT (Article 115.4)** - Classes open to riders 7 & under mounted on ponies/cobs/half-Welsh, mares and geldings. Judged on equitation and suitability of mount at a walk and trot/jog. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk and leadline walk-trot poles.

**WPCSA LEADLINE WALK-TROT POLES (Article 115.4)** - Classes open to riders 7 & under mounted on ponies/cobs/half-Welsh, mares and geldings. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or entirely at a trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk and leadline walk-trot .

**WPCSA PLEASURE DRIVING (Article 113.1)** - To be shown to a suitable two or four-wheeled vehicle or four-wheeled vehicle for pairs, but not a viceroy, racing sulky or fine harness rig. To be shown both ways of the ring at a walk, working trot and trot on and stand quietly and except for tandems, **to back readily**. To be judged 75% on performance, manners, movement and style; 25% on breed type and conformation. Working classes are judged 100% on performance.

**WPCSA RIDDEN COB WELSH CLASSIC SEC. C & D (Article 115.7)** - This class is for registered Welsh Cobs and Welsh Ponies of Cob Type 4 years of age and over. To be judged 50% on conformation and 50% on performance. Entries shall enter the arena at the walk in a clockwise direction. To be shown on both reins as a group at the walk, trot, and canter with animation. The required individual performance must show all four gaits (the gallop need only be shown in one direction). Each animal will then be stripped and judged for conformation judging, showing at the walk and trot, in hand, by the rider. Once an entry has been judged for conformation it may be retacked. Class is an English class only. No Western, Saddle Seat or Side Saddle tack or attire. Qualified UK or American Judge to officiate.

**WPCSA RIDDEN WELSH CLASSIC SEC. A&B (Article 115.7)** - This class is for registered Welsh Ponies, Section A & B, 4 year of age and over. To be judged 50% on conformation and 50% on performance. Entries shall enter the arena at the walk in a clockwise direction. To be shown on both reins as a group at the walk, trot, and canter with animation. The required individual performance must show all four gaits (the gallop need only be shown in one direction). Each animal will then be stripped and judged for conformation judging, showing at the walk and trot, in hand, by the rider. Once an entry has been judged for conformation it may be retacked. Class is an English class only. No Western, Saddle Seat or Side Saddle tack or attire. Qualified UK or American Judge to officiate.

## **WPCSA CLASS SPECIFICATIONS Continued**

**WPCSA RIDDEN WELSH CLASSIC CHAMPIONSHIP CLASS (Article 115.7)** - To be judged 50% on conformation and 50% on ridden performance. Open to first and second place winners from the Ridden Welsh A/B Classic and the Ridden Welsh C/D Classic. There is no entry fee for this class. Places will be awarded for the Best Ridden and the Reserve Best Ridden. Any animal in this class is eligible to be named the Best Ridden. Entries shall enter the arena at the walk in a clockwise direction. The Judge shall request all four gaits (walk, trot, canter, gallop) in at least one direction, but animals need not show in both directions. The judge shall consider the size of the ponies/cobs, ages of riders, safety of arena when determining whether to have the animals perform as a group or individually. Individual pattern is optional at the judge's discretion. Entries shall not be stripped as conformation score from the qualifying class shall be carried forward.

**WPCSA STOCK SEAT EQUITATION (Article 114.5)** - Classes are open to ponies/cobs/half-Welsh. Riders to be judged on seat, hands, performance of animal, appointments of animal and rider and suitability of animal to rider. Riders enter the ring at a walk or jog and are judged at a flat-footed four beat walk, two-beat jog and a three-beat lope both ways of the ring. All competitors are required to back a straight line during the line up. Tests may be required.

**WPCSA TRAIL (Article 115.3)** - Open to all ponies/cobs/half-Welsh. Junior and adult (separate divisions are to be offered for juniors and adults). English or Western equipment. To be shown over and through obstacles at a walk, optional trot or jog and optional canter or lope. To be judged 100% on performance. Juniors not to side pass or lope/canter over loose rails.

**WPCSA WALK (Article 115.5)** - Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh, mares and geldings. Judged on equitation and suitability of mount. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk-trot and walk-trot poles. To walk both ways of the ring.

**WPCSA WALK-TROT (Article 115.5)** - Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh, mares and geldings. Judged on equitation and suitability of mount. To walk and trot/jog both ways of the ring. Possible test to include: walk, trot/jog, turn, halt and rein back at spots marked. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot poles.

**WPCSA WALK-TROT POLES (Article 115.5)** - Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh, mares and geldings. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or entirely at a trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot.

**WPCSA WELSH ENGLISH PLEASURE (Article 112.3)** - To be shown at a walk, trot and canter both ways of the ring on light contact without a martingale. To be judged 75% on performance, manners, movement and style; 25 % on breed type and conformation. Working class to be judged 100% on performance.

**WPCSA WELSH WESTERN PLEASURE (Article 112.4)** - To be shown at a walk, jog and lope both ways of the ring without a martingale, on a reasonably loose rein, without undue restraint. To be judged on performance, with emphasis on manners 65%; breed type, conformation and movement 25%; appointments 10%. Working classes are judged 100% on performance.
